The 2019 Hall of Fame Inductee will be announced at the Season Launch event on Tuesday, May 28, 2019 held at The Burlington Performing Arts Centre.

Nominee: The nominee must have provided an outstanding contribution to Burlington's reputation as a city with a strong commitment to the development of cultural excellence. The nominee can be either a cultural worker, supporter of advancing performing arts in Burlington, or a performing artist. Staff and Board of Directors of The Burlington Performing Arts Centre may not nominate or be nominated for **The Burlington Performing Arts Centre Hall of Fame**.

Individual nominees must conduct the bulk of their work in Burlington **and/or** be a Burlington resident **and/or** achieved their artistic prominence in Burlington.

Group nominees must have a Burlington address **and** conduct the bulk of their work in Burlington **and/or** have achieved their artistic prominence in Burlington.
